President's Post

By the time you receive this, the Rockland County community and communities all across the United States will have celebrated Law Day. Very few of us were practicing law on February 5, 1958 when President Dwight D. Eisenhower proclaimed May 1st of each year to be Law Day in the United States. In doing so, he adopted an idea presented to him by Charles S. Rhyne, the then-President of the American Bar Association who was serving as President Eisenhower's legal counsel at the time. Law Day transitioned from a presidential proclamation to a codified statute on April 7, 1961 with the adoption of Public Law 87-20 (36 U.S.C. §113). The statute states, in pertinent part:

“Law Day, U.S.A., is a special day of celebration by the people of the United States-

- 1) In appreciation of their liberties and the reaffirmation of their loyalty to the United States and of their rededication to the ideals of equality and justice under law in their relations with each other and with other countries; and
- 2) For the cultivation of the respect for law that is so vital to the Democratic way of life.”

In these fractious times, with the Country so polarized, we are often reminded of the things that divide us as a nation and forget the things that bind us together. Unlike our English forbears, we have a written Constitution, a document unique in the history of the civilized world. Of course, today we are split down the middle over how to interpret our Constitution, with a large segment of the population supporting the conservative “originalist” interpretation, and an equally large segment of the population supporting a liberal “living” Constitution. Of course, the cynics among us would say that the Constitution means what a five to four majority of the Supreme Court says it means in any given case at any given time.

For those of us who labor daily to apply the rule of law to the myriad interactions between the citizenry of our great nation, much of the law is clear and readily recognizable as a shining beacon of what is right and good in our society.

Because our Constitution was written by men, it is an imperfect document. We have only to look at the provision counting each Negro slave as three fifths of a person to recognize that our Founding Fathers were imperfect and flawed just as we are today.

The theme of this year's Law Day celebration across the Country was “The 14th Amendment: Transforming American Democracy”. Those of us who paid attention to the year-long fight to fill the Supreme Court vacancy created by the death of Justice Scalia know that the “transformation” of our American Democracy is not yet complete but rather is a work in progress. Spring being the season of hope and renewal, one can only dream of the day when the transformation is complete and our citizens can live side-by-side in relative peace and harmony.

To all my fellow members of the Bar, I wish you a Happy Law Day and hope that the coming year is a rewarding one for you and your clients.

COMMERCIAL LITIGATION ISSUES OF INTEREST

May 2017

Your client hired an interior decorator to decorate the rooms of your client's home. The contract provided for the decorator to select and purchase furniture and other items on your client's behalf. In return, your client agreed to pay the decorator for her services, the "list price" of the items, which is the net cost to the decorator plus the standard industry mark-up as the decorator's design fee. Your client has paid most of the decorator's bills, but there is an unpaid a balance of over \$50,000, largely for the amount billed for furniture and other items. The decorator commenced an action against your client five years after the payment was due. You move to dismiss the complaint, arguing that the contract is primarily one for a sale of goods with only incidental design services, and is governed by the four-year statute of limitations for the sale of goods, as provided by UCC 2-725. The decorator counters that the contract is primarily one for design services with the incidental sale of goods, and is governed by the six-year statute of limitations for breach of a services contact under CPLR 213. Will you succeed in dismissing the complaint under the UCC's statute of limitations?

The answer is *no*.

In *Hagman v. Swenson*, 154708/15, NYLJ 1202780068520, at *1 (1st Dep't February 23, 2017), the plaintiff sued the defendant in 2015 for unpaid interior decorator services provided from December 2007 through July 2010 for three of the defendant's houses in Tuxedo Park, New York, including the defendant's home with five bedrooms and three servants' rooms. The Supreme Court dismissed the complaint, reasoning that the contact referred to "products and materials," and the amount due was largely for goods, indicating that the services were incidental and the four-year statute of limitations under UCC 2-725 applied.

The Appellate Division, First Department, modified the order to reinstate the breach of contract claim, finding that the contract was predominantly one for services, which falls under the six-year statute of limitations of CPLR 213.

While noting that no New York case specifically addresses whether an interior design contract is one for goods or services, the Court cited the general rule that contracts involving both goods and services requires a determination of whether the transaction is predominantly one for goods or one for services, citing *Levin v. Hoffman Fuel Co.*, 94 A.D.2d 640 (1st Dep't 1983), aff'd 60 N.Y.2d 665 (1983), and *Gibraltar Mgt. Co., Inc. v. Grand Entrance Gates, Ltd.* 46 A.D.3d 747 (2d Dep't 2007).

The Court supported its finding that the contract was predominantly one for services based on the plaintiff being an expert in the interior design industry; the contract provides for the designer to select products and materials, show them to the defendant, purchase them on the defendant's behalf, and charge "list price," which was net price plus a percentage service fee; certain custom work was provided; the contract provides for the designer to give advice and design suggestions regarding construction, cabinetry and painting, for which a consultation fee of \$200 would be charged; and the designer was entitled to use and publish photographs to demonstrate the designer's work.

The Court ruled that the motion court improperly focused on the bills at issue being for listed goods. However, even though the cost of materials greatly exceeds the cost of labor, "this factor should not have been the sole consideration; the court should have looked to the nature of the transaction."

The lesson?

In order to receive the benefit of the six-year statute of limitations for a client who will be providing both goods and services, add a contract provision stating that the primary purpose of the contract is the services to be provided. List the services to be provided, and clearly state the charges for those services.
